CLARIFICATION OF CMS/WPS MEDICARE GUIDELINES FOR PNEUMOCOCCAL VACCINATIONS

CMS/WPS Medicare **does not** follow Advisory Committee on Immunization Practices (ACIP) guidelines for pneumococcal vaccinations.

Medicare law only allows contractors to reimburse for a second pneumococcal vaccination 5 years after the initial vaccination is given and then only for those at highest risk. This group includes persons with:

- Functional or anatomic asplenia (e.g., sickle cell disease, splenectomy)
- HIV infection
- Leukemia
