A New Health Plan Sponsored by the State of Indiana

WHAT IS HIP?

The Healthy Indiana Plan (HIP) is a new, affordable health insurance program for low-income, uninsured adult Hoosiers. The program offers **comprehensive health benefits, including physician services, mental health services, and prescription drug coverage**. The program is subsidized by the State, and therefore, requires only minimal monthly contributions from the participant.

WHO IS ELIGIBLE?

Uninsured, low-income Hoosier adults between the ages of 18 - 64.

Eligibility requirements include:

- Income below 200% of the federal poverty level (FPL) - A single adult earning \$20,000, or a family of four earning \$40,000 is approximately at 200% FPL. The income requirements for this program are the same as Hoosier Healthwise.
- No access to employer-sponsored insurance
- No insurance coverage for the previous 6 months

OF INTEREST TO HEALTHCARE PROVIDERS

- HIP reimbursement for providers will be based on Medicare rates rather than traditional Medicaid rates.
- Only Medicaid physicians may participate in the HIP program.
- HIP will decrease the number of uninsured patients in the state.
- HIP provides \$500 of free preventive services, thus increasing utilization of all preventive care.
- HIP requires a co-payment for ER visits, and therefore hopes to decrease inappropriate ER utilization from this population.
- Indiana Check-Up, the total package in which HIP is included, provides for a physician reimbursement increase taken from the cigarette tax.
- HIP will be administered by two insurance carriers.
