About the 2021 Opioid CME Series presented by ISMA

- Expert presenters discuss best practices and other important information on caring for patients with or at risk for opioid use disorder (OUD) in a variety of settings.
- Live webinars occur on the second Thursday of every month in 2021 and can be viewed on your desktop computer or mobile device. Recordings of each live webinar are archived on the ISMA Online™ mobile learning app for later viewing. Additional recorded courses continue to be added to the mobile app.
- Each webinar counts toward fulfilling Indiana's requirement that prescribers must have earned 2.0 hours of CME on opioid prescribing or abuse in the previous two years to obtain or renew a CSR in 2021.

How to access the 2021 Opioid CME Series presented by ISMA

- ISMA members get free access to all live webinars in the series as well as content on the ISMA Online™ mobile learning app, including archived recordings.
- Nonmembers can subscribe to all ISMA Online content through Dec. 31, 2021, for a one-time fee of \$400. Or, for a better value, physicians may join ISMA any time in 2021 and get immediate access to all courses in the series at no extra charge.
- Advanced practice registered nurses (APRNs) and physician assistants (PAs) who work with ISMA members can subscribe to content on the ISMA Online app for just \$100 – a 75% discount on the regular cost of a subscription.
